Módhanna Imeachta sa Scoil

- Má tá sé riachtanach do do pháiste fón póca a bheith acu ar scoil toisc é a bheith ag teastáil díreach i ndiaidh am scoile caithfear glacadh leis na rialacha thíos luaite. **Is gá cead scríofa a fháil ón scoil.** Foirmeacha le fáil san oifig.
- Caithfidh an fón a bheith múchta ar fad agus na páistí ar shuíomh na scoile.
- Feictear ar thaifead fuaimne nó ar íomhánna gan chead mar iompar an-tromchúiseach nach bhfuil inghlactha, fch Cód Iompair.

- Má bhíonn fón póca ar siúl ag páiste le linn am scoile, tógfar an fón ón bpáiste agus beidh ar thuismitheoir an pháiste teacht agus é a bhailiú ón oifig.
- Is féidir glaoch ar thuismitheoirí ón bhfón oifige i gcás práinneach.
- Ní ghlacann an scoil aon fhreagracht i leith fóin póca aon pháiste. Má dhéantar dochar do fón, má ghoidtear é nó má chailltear ar láthair na scoile é, ní bheidh an scoil freagrach as an bhfón a athchur. 'Sé freagracht iomlán an dalta nó an tuismitheora sábháilteacht an fóin póca.
- Is cion coiriúil é fón póca a úsáid chun cur isteach ar dhuine, duine a chiapadh nó duine a chiontú. Déan tagairt dár gCód Iompair agus dár bPolasaí Faoi Chíbearbhulaíocht.


Úsáid Foirne Fóin Póca



Mobile Phone \ Electronic Devices Policy



Introduction

It is recognised that mobile phones are common tools in our lives today and they can be useful for a child to have but they can be misused. In the interest of Health and Safety and also being mindful of Child Protection issues the Board of Management of Gaelscoil Uí Fhiaich have agreed that pupils must not bring mobile phones to school.

Aims

The aims of the policy are:

- To provide a safe school environment
- To lessen intrusions on and distractions to children's learning
- To decrease the opportunity to conduct bullying in any form

Internal School Procedures

- Special conditions apply and must be adhered to if it is deemed absolutely necessary for a child to have access to their mobile phone immediately after school. **Written approval must be obtained from the school.** Forms are available from the office.
- Mobile phones must be turned off while children are on the school premises.

- Unauthorised recording of audio / images is considered very serious unacceptable behaviour, see Code of Behaviour.
- If pupils have mobile phones turned on during school time their phones will be confiscated and will have to be collected by their parent from the office.
- Students have access to the school landline if urgent calls need to be made to parents.
- The school accepts no responsibility for replacing lost, stolen or damaged mobile phones. The safety and security of mobile phones lies with the child and their parents.
- It is a criminal offence to use a mobile phone to menace, harass or offend another person. Refer to our Code of Behaviour and our Anti-Cyberbullying Policy.


Mobile Phone Use by Staff

- It is accepted that staff use of mobile phones can be for educational purposes e.g. Class Dojo, etc.
- Personal use of staff mobile phones will be confined to break times and before and/or after school (except in case of emergency).


This policy will be monitored on an ongoing basis and amendments added as new technology comes on stream.
